## New Beginnings

I will be newly married at the time you read this. It will be the beginning of long summer days. It is also the start of a new bar year. New beginnings. There is something so great about the start of something new – the anticipation and excitement fill me up. I recall that first summer after law school, so excited by the thought that the worst was over but dreading the bar exam in just a matter of weeks. I've learned that excitement is contagious and so I am sharing mine with you all for the upcoming bar year.



First, as you are likely aware, three of Minnesota's bar associations (Minnesota State, Hennepin County, and Ramsey County) have merged their back-end and administrative functionality, the goal being to better utilize the skills of the combined bar staff to improve the member experience. There are obvious challenges for our profession, and ensuring costs are scrutinized and put to their most beneficial use has guided these decisions. While the back-end functionality has merged, each entity distinctly retains their own personality and traditions. While I certainly think the RCBA is the best of the bunch, not only because we are in the capital city, and closest to the high courts, we will certainly gain information and enhance member offerings as we learn throughout this joined effort. The goal is that all members from each organization gain from these efforts – from solo practitioners, to out-state attorneys, to in-house counsel, and large firms.

Second, there is a renewed and dedicated focus on improving the health of our profession. This is about ensuring lawyers are healthy, productive, and happy in our work. Several months ago, the Minnesota Supreme Court's Call to Action on Lawyer Well-Being was launched. Approximately 250 attended the event in an effort to understand and discuss the concerns facing our profession and start putting together



action plans to address this issue. These concerns include the increasing substance abuse, depression, anxiety, stress, and job dissatisfaction. Improving our overall health is not only the right thing to do in our profession, it impacts the success of our legal organizations, and promotes a positive public perception of our profession. There is newness in the bar. Our primary goal is to ensure we are creating and building upon value for all members. However, we should all share in the efforts to strengthen our profession's health. That may mean having difficult conversations, reaching out to others who may be struggling, and helping guide and mentor those newest to our profession.

I hope to meet many of you throughout this upcoming year and hear about opportunities you feel could help enhance the RCBA's value, or what you or your firm is doing to strengthen our profession.

## Profile: Monica Dooner Lindgren



I began my interview of RCBA in-coming Vice President Monica Dooner Lindgren by asking her three questions that I often use during jury selection: What are you most passionate about? What organization is most important to you? And, what irritates you? In response to the first question, Dooner Lindgren's eyes lit up, she

flashed a radiant smile and said, "That's easy, I am passionate about helping people." Her response began a 40 minute conversation about Dooner Lindgren's life story that began in Colombia, South America, traveled through Northeast Minneapolis, St. Olaf College, Hamline Law School and recently, to Washington D.C. While connected to many organizations dedicated to supporting Latinx immigrants and the adoption community, one of the most important organizations to her is Casa de Esperanza, the largest Latina organization in the country focused on domestic violence. When asked what irritates her, she responded with "injustice."

"... I am passionate about helping people." Her response began a 40 minute conversation about Dooner Lindgren's life story that began in Colombia, South America, traveled through Northeast Minneapolis, St. Olaf College, Hamline Law School and recently, to Washington D.C.

The single, most formative event of Dooner Lindgren's life was being adopted out of an orphanage in Colombia by two loving parents and being raised in Minnesota by a family that encouraged her to explore her identity. At age 13, Dooner Lindgren began taking Spanish in school and by the time she graduated from high school, she was fluent in reading and speaking Spanish. She has traveled to Colombia three times and has visited the orphanage where she lived as a baby. She is well aware of the contrast between what her life would have been in Colombia compared to the opportunities her life in Minnesota provided her. The fact that she was "given a chance at life," she developed an intense desire to help others and her Latina heritage has caused her to direct her efforts primarily towards the Latinx community.

At St. Olaf College, Dooner Lindgren focused her educational efforts on Spanish and Hispanic Studies. During law school, her concentration was Children and the Law. She also served a Minnesota Justice Foundation clerkship at Southern Minnesota Regional Legal Services,

Inc. (SMRLS). After law school, she worked as a criminal law clerk, as a grant writer at La Familia Guidance Center, and served as an Immigrant Community Constituents Advocate for U.S. Senator Amy Klobuchar.

In January 2008, Dooner Lindgren began her work as a Staff Attorney with SMRLS where she has provided bilingual and bicultural legal services to low-income persons in contested family law proceedings, with an emphasis to victims of domestic violence. She is now a Senior Attorney representing crime victims in civil matters. She describes her work at SMRLS as her "dream job" because it combines her legal education and her desire to help people with her dedication to the Latinx community. She thinks of SMRLS as the legal "emergency room" that works on behalf of people who often do not have a voice due to many barriers placed before them. Her professional and personal goal is to free her clients from abuse, help them to receive the benefits to which they are entitled and empower them to independently move forward.

Dooner Lindgren met her husband, Miguel, who was also adopted into a Minnesota family from Colombia, while volunteering at Children's Home Society/Lutheran Social Services. They have one daughter, Camila, who they adopted from Colombia just 2 years ago at 7 years of age. Camila and her mom are members of a Colombian folk dance group, Grupo de Danzas Colombianas MN, continuing Dooner Lindgren's passion and commitment to her Latina heritage.

Recently, Dooner Lindgren was selected to participate in a dialogue session on inter-country adoption with the U.S. Department of State's Office of Children's Issues, Domestic Policy Council and adoption professionals from around the country at the White House. There is no doubt that she will bring her unique perspective and commitment to helping others with unbridled enthusiasm.

Our in-coming Vice President was initially drawn to the RCBA through her participation in the Minnesota Hispanic Bar Association. She believes that the voices of legal aid attorneys and attorneys of color provide an important perspective to the entire bar association. During this new, exciting time for the RCBA, she is looking forward to bringing that perspective to her colleagues at the bar association.

## Congratulations Melitta Drechsler, Recipient of the 2019 Excellence in Diversity Award



**MELITTA DRECHSLER** is, and has been, a tireless promoter and supporter of the personal and professional development of Asian Pacific American lawyers, judges, and law students in the local community, as

well as on the national stage. She is the 2019 recipient of the RCBA's Excellence in Diversity Award.

Melitta Drechsler (formerly Melitta George) currently serves as an Assistant Ramsey County Attorney in the Ramsey County Attorney's Office. She has worked in the office's Civil Division since October 2014, where she supports the County's Property Tax department as well as the 911 Center and the County's workforce development efforts. Previously, Drechsler was instrumental in drafting and negotiating Ramsey County's high-dollar-value procurement contracts. Prior to joining the Ramsey County Attorney's Office, she worked as corporate counsel for Taylor Corporation in Mankato, and for five years as an associate in the business law section of Briggs and Morgan.

Drechsler has championed the Asian Pacific American (APA) legal community ever since her first year in law school in 2005, when she served as the Northwest Regional Director for the National Asian Pacific American Law Student Association (NAPALSA).

She has maintained her commitment to the APA community throughout her legal career through her involvement with the Minnesota Asian Pacific American Bar Association (MNAPABA) and the National Asian Pacific Bar Association (NAPABA). NAPABA is the national bar association for APA lawyers, judges, and law professors. Drechsler was President of MNAPABA for the 2017-2018 bar year.

Through her work in these organizations, Drechsler has proven a dedicated and accomplished leader in the APA legal community. As chair of MNAPABA's Award Committee and President of MNAPABA, she has given her time and talents to help many MNAPABA members gain recognition, achieve national awards, and advance in their legal careers. Drechsler has supported MNAPABA's tradition of actively assisting its members seeking judicial appointments by holding mock interviews with applicants

and providing endorsement letters to the Minnesota Judicial Selection Commission and members of the Congressional judiciary committee. She organized and hosted several CLEs concerning aspects of professional development and diversity. Drechsler began a CLE series in partnership with national corporations headquartered in the Twin Cities. She also helped MNAPABA host a Government/Nonprofit Careers Panel at Twin Cities Public Television and worked to draw a record number of sponsorships for the association's 2018 Annual Gala.

Drechsler is now supporting the next generation of leaders as Immediate Past President of MNAPABA, and her legacy of promoting the representation of the APA community on the Bench and in the Bar continues. She serves as a mentor and friend to new attorneys and law students. MNAPABA and the greater APA community owe Drechsler a tremendous debt of gratitude for her tireless efforts to foster diversity and APA representation in the legal community. She exemplifies the Ramsey County Bar Association Diversity Committee's mission in promoting diversity and equal opportunities through her unflagging work in serving and promoting the Asian Pacific American community.

Drechsler is a 2008 graduate of the William Mitchell College of Law. She received her undergraduate degree in piano performance from the University of Kansas and her Masters of Philosophy in music from the University of Birmingham in England. She is married to Joseph Drechsler and the mother of two young sons.

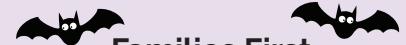
