2021 RCBA Award Recipients

The Ramsey County Bar Association is presenting its Distinguished Humanitarian Service Award and the Liberty Bell Award on May 12, recognizing service to the local legal profession and community. The 2021 awards will be presented at the association's annual Member Appreciation Day event, to be held via remote participation this year. Visit www.ramseybar.org for event and awards information.

Distinguished Humanitarian Service Award: Veena lyer

The Distinguished Humanitarian Service Award is given to an individual who demonstrates outstanding professional performance, leadership in the development of law in the community, and a commitment to humanitarian service to the bar and the Ramsey County community. The 2021 recipient, Veena lyer, currently serves as Executive Director of the Immigrant Law Center of Minnesota (ILCM). Iyer and the team at ILCM provide immigration legal services to low-income immigrants throughout the state and engage in advocacy and education efforts to support access to justice. Previously, Iyer was a shareholder at the law firm of Nilan Johnson Lewis, practicing labor and employment law. Her work at ILCM is a culmination of a career of humanitarian service that has benefitted not only the residents of Ramsey County, but the greater community throughout Minnesota.

Liberty Bell Award: Center for Excellence in Supported Decision Making (CESDM)—Volunteers of America Minnesota and Wisconsin

The RCBA Liberty Bell Award is given each year to recognize non-lawyers who have been involved in activities that promote a better understanding of the law and our government. The 2021 recipient, Center for Excellence in Supported Decision Making, was instrumental in working with the Minnesota State Bar Association attorney drafting committee to develop and update Minnesota guardianship law. CESDM regularly offers educational opportunities to attorneys through CLE programs, and services to the community. CESDM's staff consists of social workers Kathleen Carlson, Amanda Hudson, and Anita Raymond. John Kantke is the Managing Attorney for Volunteers of America/Estate and Elder Law Services, the non-profit firm that works with CESDM. In 2016, Volunteers of America Minnesota and Wisconsin opened the CESDM to promote safe and viable alternatives to guardianship and conservatorship in Minnesota.

Looking Back ...

Thank you for the opportunity to represent RCBA in our professional community throughout the bar year. 2020-2021 has been a year like no other. Shortly after RCBA Past President Sarah McEllistrem passed the gavel—virtually—to me, we learned of George Floyd's tragic death; and now, more recently, we witnessed the death of Daunte Wright at the hands of law enforcement. As expressed in the joint MSBA, HCBA, RCBA and Federal Bar Association Minnesota Chapter Presidents' statement: "The bar associations stand with our colleagues of color in grieving this latest senseless loss. ... The bar associations strive to improve society by developing professional excellence among its diverse membership. One of the core components of its mission is to provide valued resources to its members."

The Bar remains dedicated to addressing issues of diversity and inclusion in the profession and society. In April, MSBA, HCBA, RCBA, Twin Cities Diversity in Practice and Lawyers Concerned for Lawyers sponsored "Listening & Support Sessions-Space for Lawyers Experiencing Distress in the Midst of Derek Chauvin Trial and Daunte Wright Killing." The RCBA New Lawyers section also sponsored "Discriminatory Covenants and the Just Deeds Project—Acknowledging the History of Systemic Racism in Housing." These presentations were excellent and I urge you to seek out similar resources. The MSBA homepageii and Lawyers Concerned for Lawyers, www.MNLCL.org,iii both have resource pages available on their websites. Looking ahead, please join me on Wednesday, May 19th for the RCBA Law Day CLE: Reconsidering Criminal Justice After the Death of George Floyd, co-hosted by the Ramsey County Law Library (full program details on page 8).

Many of us have had family and friends inquiring about news headlines and the Chauvin trial. While we may not be criminal law practitioners, we must help build trust and confidence in the rule of law. In her March President's Page, current MSBA President Dyan Ebert reminds us to "commit to educating the people in your circles about the rule of law. Together, let's rebuild trust and confidence in this ideal we hold so dear..." Ms. Ebert asks us to make this

commitment because "the most important professional obligation we have is to defend the rule of law." As Ms. Ebert thoughtfully explains, the obligation to defend the rule of law is embedded in our Rules of Professional Conduct (Minn. R. Prof. Conduct, Preamble ¶6). Moreover, a peaceful society depends on the rule of law, and as attorneys, we have a special obligation to ensure that the rule of law does not fall by the wayside as people struggle with actions of the police.

Finally, as RCBA members, we have the knowledge and skills to give back to the profession and to our community through our involvement with the Bar Association. Thank you for giving me the opportunity to serve, (thanks to my supportive family!) and thanks to the staff, and the RCBA Board of Directors and Executive Committee. Thank you to RCBA volunteers, especially section and committee chairs, for their time and effort in making my term as president successful, even amidst a pandemic. Section co-chairs plan CLEs, recruit speakers, and host CLE sessions. Committee co-chairs spend countless hours to plan events and to make it easy for us to participate in those events as much as our schedules permit. Foundation Focus:

Loan Repayment Assistance Program of Minnesota



Loan Repayment Assistance Program of Minnesota (LRAP) has been around for 30 years. Its mission is to help reduce the education debt burden experienced by dedicated public interest lawyers who represent low-income clients seeking legal services to secure essential needs like food, shelter and safety, and fundamental rights like equal access to justice. "Our mission grounds our work," said Dee Baskin, executive director of LRAP.

Student loan debt is the same no matter the job, but legal aid attorneys earn one-third of what their counterparts at major law firms earn. In most cases, they do not receive bonuses or additional benefits. It can be difficult for legal aid attorneys, facing high student loan debt, to pay basic expenses such as rent or mortgage, car payments or public transportation fees, and the increasing costs of childcare, if applicable. Not to mention the struggle to put money into savings for emergencies or other needs. LRAP exists to fill this gap. LRAP provides loan repayment assistance to nearly 50 public service attorneys—who serve 10,000 low-income Minnesotans—each year. The lives of low-income clients are profoundly impacted by the services these attorneys provide.

Grants from foundations and law firms, as well as individual donations, go directly to paying the loans of legal aid attorneys. During a typical year, LRAP offers two application cycles. An awards committee, composed of members of the LRAP Board of Directors, reviews all applications. Applicants are legal aid attorneys with a demonstrated financial need working in Minnesota.

LRAP applicants could have up to \$200,000-\$300,000 in debt. The awards committee aims to relieve a significant portion of income-driven repayment amounts for all qualified applicants. However, based on funding and number of applications, it could vary. LRAP prioritizes years of experience in legal aid

employment as they help applicants work toward public service loan forgiveness after 10 years.

Legal aid organizations do not want high turnover. Experienced attorneys, those who can handle a larger volume of complex cases, are needed and valued in the legal aid field. "A lot of people leave legal aid because they cannot afford to be there," said Baskin, "It is so important that we have as many attorneys as possible handling increasing caseloads." The volume and quality of work provided by legal aid attorneys would not be possible without LRAP. Without loan help from LRAP, many attorneys would be forced to leave the work they love—work that helps low-income members of the community—for private-sector employment.

One such attorney is Katie Allen of Neighborhood Justice Center in St. Paul. Allen represents clients at Ramsey County's Mental Health Court. This role allows her to spend extra time with each client to determine their mental health needs. She recently helped a young man who had been experiencing homelessness receive in-patient treatment instead of jail time for mental illness and chemical dependency. Over the last year—especially with prominent law enforcement sweeps of homeless encampments, and other instances of housing insecurity related to the COVID-19 crisis—these services have become more important than ever.






